Any institution or association related to the F&B industry and duly registered with the relevant authorities of Singapore.

Submission Requirements:

- Completed all sections of Membership Application Form (all five sections) and duly signed by authorised signatory
- Latest ACRA search or instant information (Not more than six months old)
- Cheque for membership application

3) Individual Associate Member

Any individual working in F&B industry and duly recognised as a legal resident by the relevant authorities of Singapore.

Submission Requirements:

- Completed sections of Membership Application Form (only Sections 1, 2, 4 and 5) and duly signed by authorised signatory
- Scanned or photocopy of NRIC or Passport and valid working pass
